MEASURING and HEIGHT CARD INFORMATION

Effective January 1, 2010, exhibitors are no longer required to provide proof to Trial Secretaries that their dog has a valid jump height card as part of the check-in process. Furthermore, this change eliminates the need for a copy of the jump height card to be submitted with an entry form. Dogs without a valid Jump Height Card/Form may still compete. Measurements shall be performed in accordance with the AKC Suggested Best Policies in effect at the time of the trial and may not require the Judge of Record to measure any dogs. If a **Volunteer Measuring Official (VMO)** or an **Agility Field Rep** is present, **ALL** dogs without a valid Jump Height Card/Form may be measured at the discretion of the VMO or Agility Field Rep during the trial or cluster of trials. This does not preclude having the dog wicketed by the Judge of Record if the VMO or Rep is not available to measure the dog before its first run of the trial or cluster of trials. It is the exhibitor's responsibility to have their dog measured prior to running if measurements are being performed. Failure to do so will result in the cancellation of any qualifying scores.

Simplified Jump Height Card Process

When filling out the entry form, there is a new section at the top of the form for exhibitors to designate whether your dog needs to be officially measured. Please check the box so that the Trial Secretary knows whether to include your dog on the Dogs To Be Measured List. It is no longer required that you submit a copy of your dog's jump height card with your entry form or show it during day of show check-in.

DOGS ELIGIBLE TO ENTER

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), or approved Foundation Stock Service (FSS) breeds are eligible to participate. Entries are open to All-American/Mixed Breed dogs listed in the AKC Canine Partners program. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate.

Dogs should be physically sound. Dogs that are blind shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate. Puppies under four (4) months of age are strictly prohibited from the trial grounds.

COURSE WALK-THROUGHS AND WARM-UP INFORMATION

Handlers in all classes are permitted to walk the course, without a dog, during a walk-through period held prior to the start of the class. The walk-through is restricted to handlers entered in that class only. Handlers with multiple dogs may request to walk with a height group other than the one their dog is entered in if a conflict is imminent.

A warm-up area, consisting of a regulation agility jump, may be provided for exhibitors. The warm-up area is to be used exclusively for warming up the dog and not for training or relieving of the dog.

OBSTACLES AND RING CONDITIONS

Obstacles will meet the specifications outlined in the current edition of the Regulations for Agility Trials and are supplied by Oriole Dog Training Club. All classes will take place indoors on Sprinturf. Ring size is 90' x 93' with 3 pillars in the ring. Electronic timers will be used.

FOR EXHIBITION ONLY (FEO) & FIX N GO ON (FNG)

FEO allowed in ALL CLASSES this weekend!

Entering For Exhibition Only (FEO) –

- FEO runs are treated as trial entries. The exhibitor must enter the class(es) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler will declare the day of the show.
- Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed.
- Dogs may be entered in any level of FAST (Novice, Open, Excellent, Master). If the dog is not eligible for the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.
- The exhibitor must declare FEO in the ring, prior to leading out, to the scribe and the judge.

Fix and Go On (FNG) - Fix and Go On is not pre-entered; rather, it occurs during the course of the run. FNG allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying score.

NOTICE TO EXHIBITORS

The building will open at 4:00 p.m. on Friday, and 6:30 a.m. on Saturday & Sunday. Friday, you may enter and setup as early as 4 p.m.; however, dogs are not allowed in the building prior to 5:00 p.m. unless they are required to be measured and will not bark (landlord requirement Monday through Friday only). At the time of publishing this premium we expect that crating WILL be allowed indoors. Full information will be provided in the judging schedule. The event site requires a tarp to be placed on the floor underneath your crates. Crates may be left overnight; however, ODTC will not be responsible for any lost or damaged items left at the show site. Dogs may not be left overnight.

Food will NOT be available on-site.

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations on the show grounds

Exhibitors are responsible for being at the ring gate when it is their turn to run.

All dogs must be on a leash at all times when on the trial grounds except when in the designated warm-up area or competing on the course.

SAFETY, BEHAVIOR and LIABILITY

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. Oriole Dog Training Club (ODTC) and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. ODTC reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against ODTC or any official thereof.

All dogs should be pottied only in designated areas and not around buildings or other tenants' property. More information will be provided prior to the start of the trial and at general briefings.

REFUNDS

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee.

Bitches in season <u>are not</u> permitted to compete in agility trials. ODTC will refund all but \$10 dollars per run for bitches unable to compete for that reason upon presentation of a note from a veterinarian stating that the bitch is in season.

Medical condition: Dogs that cannot compete due to an injury or illness where a veterinarian determines that the dog should not run and provides a note, ODTC will refund all but \$10 dollars per run.

Deceased Dog: A full refund will be made provided the Trial Secretary receives written or emailed notification prior to the start of the trial. A note from a veterinarian is <u>not</u> required.

Veterinarian Notes must be signed, dated after the closing date, on official business letterhead, state owner and/or dog name, state the reason that the dog/handler may not compete and be presented to the Trial Secretary no later than one half hour prior to the start of judging on the last day of the trial. After that time, refund requests will not be accepted. Please note: Phone calls, "text only" e-mails, and non-letterhead notes will not be considered. Vet notes may not be written by owner, handler, or immediate family member.

RINGSIDE

Dogs may arrive any time prior to judging if the dog has a valid temporary or permanent jump height card. Otherwise, they must be available for measuring prior to the start of their class if a VMO or AKC Field Rep is available to measure dogs. All dogs not needed for further judging will be excused.

This club does not agree to arbitrate claims as set forth on the Official AKC Entry Form for this event.

RIBBONS, AWARDS, AND PRIZES

Ribbons will be awarded for first through fourth place in each jump height in every class. Dogs must qualify to receive placement ribbons. Qualifying ribbons will be awarded to all dogs receiving qualifying scores.

A rosette will be offered to all dog/handler teams finishing a title.

A bar will be offered to teams finishing their MACH, PACH, or PAX.

A ribbon will be given for a perfect score not earned in the Master Classes

A ribbon will be given for a double-Q earned from the Master Classes.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned partiess from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other person. I (we) agree that the determination of whether the injury is serious shall be made by the event veterinarian and is binding on me (us).

I (WE) AGREE THAT ANY CAUSE OF ACTION, CONTROVERSY OR CLAIM ARISING OUT OF OR RELATED TO THE ENTRY, EXHIBITION OR ATTENDANCE AT THE EVENT BETWEEN THE AKC AND THE EVENT-GIVING CLUB (UNLESS OTHERWISE STATED IN THIS PREMIUM LIST) AND MYSELF (OURSELVES) OR AS TO THE CONSTRUCTION, INTERPRETATION AND EFFECT OF THIS AGREEMENT SHALL BE SETTLED BY ARBITRATION PURSUANT TO THE APPLICABLE RULES OF THE AMERICAN ARBITRATION ASSOCIATION. HOWEVER, PRIOR TO ARBITRATION ALL APPLICABLE AKC BYLAWS, RULES, REGULATIONS AND PROCEDURES MUST FIRST BE FOLLOWED AS SET FORTH IN THE AKC CHARTER AND BYLAWS, RULES, REGULATIONS, PUBLISHED POLICIES AND GUIDELINES.

INSTRUCTIONS

Handlers may opt to enter in a **higher height** division for all **Regular** titling classes, but not in a division lower than their proper height division. Dogs entered in the Preferred classes **must** compete at the required jump height and may not compete in a jump height **higher or lower** than their proper height division.

Measurements shall be performed in accordance with the AKC Suggested Best Policies in effect at the time of the trial and may not require the Judge of Record to measure any dogs. If a **Volunteer Measuring Official (VMO)** or an **Agility Field Rep** is present, **ALL** dogs without a valid Jump Height Card/Form may be measured at the discretion of the VMO or Agility Field Rep during the trial or cluster of trials. This does not preclude having the dog wicketed by the Judge of Record if the VMO or Rep is not available to measure the dog before its first run of the trial or cluster of trials. It is the exhibitor's responsibility to have their dog measured prior to running if measurements are being performed. Failure to do so with result in cancellation of any qualifying scores.

Dog listed in the **AKC Canine Partners Program** may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler Number on the front of this form. Should you not have your Junior Handler number, it may be obtained from AKC by calling 919-233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner?
